Your advice on 6th July '21 to my '**Internet Service Provider (1 & 1 IONOS UK Ltd)**' to suspend '**grammashealth.com**' account, serves as further proof of your aggressive tactics in order to force me to comply '**under duress**' with 'a contract and jurisdiction' which does not exist.

***You did this fully aware that you have -***

- Failed to rebut my '**Affidavit of Truth**' dated 2 February 2021 (including follow up reminders dated 4th & 13th March '21).
- Failed to answer the '**Notice of Interest**' dated 6th May '21.
- Failed to answer the '**Notice of Fault & Opportunity to Cure**' dated 19th May '21.
- Failed to acknowledge, answer or apologize for your Investigation Officers sinister actions and misconduct detailed in the '**Notice of Questioning**' dated 26th May '21.
- Failed to answer the '**Certificate of Default**' dated 18th June'21.

***As well as, failed to provide -***

- Proof that information confirming the 'health benefits' of the ingredients in my Specialist Herbal Products are 'untrue'.
- Proof of 'contract and Jurisdiction'.

***With this in mind, you are further aware that in the 'Affidavit' I declared that -***
